## **Description Of Change**

Assembly site transfer of 64L 7x7 LQFP package from Carsem, Malaysia to Amkor Technology Korea(ATK).

Die Attach Change

Die attach material will change from Loctite QMI519 to 8361J which is a qualified die attach material set at in ADI.

Marking Method Change Marking process will change from ink mark to lasermark.

## **Reason For Change**

#### Assembly Site Change

Analog Devices is transferring the 64 LD 7x7 LQFP from Carsem to Amkor Technology Korea(ATK), in order to consolidate ADI's manufacturing locations. Carsem will also no longer support production of this package.

#### Die Attach Change To standardize material set

#### Marking Method Change

ADI is already in production with laser mark for many package families. The industry trend is toward ink mark elimination in favor of laser mark. This aligns with supplier direction and industry environmental initiatives.

## Impact of the change (positive or negative) on fit, form, function & reliability

Device quality, reliability, function, and performance, as specified on Product Data Sheets, will not be affected by this assembly site transfer change.
